6. Entrant must agree to attend the Mrs. America pageant if selected as the winner in the state contest, and further abide by all the required services, rules and regulations governing this pageant.
7. Entrant may have a modeling, commercial tie-up, personal management and/or agency contract, which contract however does not include, authorize or permit the use of the name of Mrs. America pageant or any title designation or reference with respect to the pageant in any matter.
